PRELIMINARY EXAMINATION

PAPER I-GENERAL STUDIES

- Current events for national and international importance.
- History of India (With special reference to Maharashtra) and Indian National Movements.
- Maharashtra, India & world Geography – Physical, Social & Economic Geography of Maharashtra, India & the World.
- Maharashtra & India - Polity and Governance - Constitution, Political System, Panchayati Raj, Public Policy, Rights Issues, etc.
- Economic and Social Development Sustainable Development, Poverty, Inclusion, Demographics, Social Sector initiatives, etc.
- General issues on Environmental Ecology, Bio-diversity and Climate Change-that do not require subject specialization.
- General Science.

Paper II-CSAT (Qualifying only)

- Comprehension
- Interpersonal skills including communication skills;
- Logical reasoning and analytical ability
- Decision-making and problem-solving
- General mental ability
- Basic numeracy (numbers and their relations, orders of magnitude, etc.) (Class X level).

MAIN EXAMINATIONA

Qualifying Paper of Marathi Language: (PAPER-A)

The aim of the paper is to test the candidates ability to read and understand serious discursive prose, and express his ideas clearly and correctly in Marathi Language. The pattern of questions is broadly as follows:

- Comprehension of given passages
- Precis writing
- Usage and Vocabulary
- Short Essays
- Translation from English to Marathi and vice-versa.

PAPER-I

Essay:

Candidates will be required to write an essay on a specific topic. The choice of subjects will be given. They will be expected to keep closely to the subject of the essay to arrange their ideas in orderly fashion, and to write concisely. Credit will be given for effective and exact expression.

PAPER-II

General Studies-I: Indian Heritage and Culture, History and Geography of the World and Society with some weightage to Maharashtra.

- Indian culture will cover the salient aspects of Art Forms, Literature and Architecture from ancient to modern times.
- Bhakti movement and its philosophy with special reference to saints movement in Maharashtra.
- Modern Indian history from about the middle of the eighteenth century until the present. significant events, personalities, issues
- The Freedom Struggle - its various stages and important contributors (contributions from different parts of the country).
- Post-independence consolidation and reorganization within the country
- History of the world will include events from 18th century such as industrial revolution, world wars, withdrawal of national boundaries, colonization, decolonization, political philosophies like communism, capitalism, socialism etc. their forms and effect on the society.
- Salient features of Indian Society, Diversity of India.
- Role of women and women's organization, population and associated issues, poverty and developmental issues, urbanization, their problems and their remedies.
- Effects of globalization on Indian society
- Social empowerment, communalism, regionalism & secularism.
- Salient features of world's physical geography,
- Distribution of key natural resources across the world (including South Asia and the Indian sub-continent); factors responsible for the location of primary, secondary, and tertiary sector industries in various parts of the world (including India).
- Important Geophysical phenomena such as earthquakes, Tsunami, Volcanic activity, cyclone etc. Geographical features and their location- changes in critical geographical features (including water-bodies and ice-caps) and in flora and fauna and the effects of such changes.

PAPER-III

General Studies II: Governance, Constitution, Polity, Social Justice and International relations with some weightage to Maharashtra.

- Indian Constitution- historical underpinnings, evolution, features, amendments, significant provisions and basic structure.
- Functions and responsibilities of the Union and the States, issues and challenges pertaining to the federal structure, devolution of powers and finances up to local levels and challenges therein.
- Separation of powers between various organs dispute redressal mechanisms and institutions.
- Comparison of the Indian constitutional scheme with that of other countries Parliament and State Legislatures-structure, functioning, conduct of business, powers & privileges and issues arising out of these.
- Structure, organization and functioning of the Executive and the Judiciary Ministries and Departments of the Government; pressure groups and formal/informal associations and their role in the Polity.
- Salient features of the Representation of People's Act.
- Appointment to various Constitutional posts, powers, functions and responsibilities of various Constitutional Bodies.
- Statutory, regulatory and various quasi-judicial bodies.
- Government policies and interventions for development in various sectors and issues arising out of their design and implementation.
- Development processes and the development industry- the role of NGOs, SHGs, various groups and associations, donors, charities, institutional and other stakeholders.
- Welfare schemes for vulnerable sections of the population by the Centre and States and the performance of these schemes; mechanisms, laws, institutions and Bodies constituted for the protection and betterment of these vulnerable sections.

- Issues related to direct and indirect farm subsidies and minimum support prices; Public Distribution System- objectives, functioning, limitations, revamping; issues of buffer stocks and food security, Technology missions; economics of animal-rearing.
- Food processing and related industries in India-scope and significance, location, upstream and downstream requirements, supply chain management.
- Land reforms in India.
- Effects of liberalization on the economy, changes in industrial policy and their effects on industrial growth.
- Infrastructure: Energy, Ports, Roads, Airports, Railways etc.

- Attitude: content, structure, function; its influence and relation with thought and behavior, moral and political attitudes; social influence and persuasion.
- Aptitude and foundational values for Civil Service, integrity, impartiality and non-partisanship, objectivity, dedication to public service, empathy, tolerance and compassion towards the weaker-sections.
- Emotional intelligence-concepts, and their utilities and application in administration and governance.
- Contributions of moral thinkers and philosophers from India and world,
- Public Civil vice values and Ethics in Public administration: Status and problems; ethical concerns and dilemmas in government and private institutions; laws, rules, regulations and conscience as sources of ethical guidance, accountability and ethical governance; strengthening of ethical and moral values in governance; ethical issues in international relations and funding: corporate governance.
- Probity in Governance: Concept of public service; Philosophical basis of governance and probity, Information sharing and transparency in government, Right to Information, Codes of Ethics, Codes of Conduct, Citizen's Charters, Work culture, Quality of service delivery. Utilization of public funds, challenges of corruption.
